

## Australia Tourist Visa

- **Original & all old Passports:**
  - **Note:** Passport should be valid minimum 06 months from the date of travel, Passport has been issued within 10 years and validity must not exceed 10 years, no hand written passports will be accepted
- **Photograph:**
  - 04 recent photograph of 35\*45 mm size, white background, matt finish & 80% face image & not used in previous visa
- **Financials:**
  - 03 years Personal Income Tax Returns with computation of Total Income Page
  - 06 months Personal original Bank Statement updated with sufficient balance
  - Copy of Investments like (P.P.F., Share Demat A/c Statement, F.D., L.I.C. Surrender value, etc.)
  - Certification of your total movable Property by Chartered accountant
- **For Employee:**
  - Leave sanction letter and N.O.C.
  - Salary Slip (last 6 months)
  - G.P.F (for Government Employee)
- **For Self-Employed:**
  - Business letterhead with sign & stamp & visiting card
  - Business Proof (Shop & Establishment, G.S.T., C.S.T., etc.)
  - Partnership Deed
  - Memorandum of Article
  - 03 Years Income Tax Return with computation of Total Income Page
  - 06 Months Bank Statement
- **For Retired:**
  - Retirement letter from Employer
  - Pension passbook copy
  - Provident Funds copy
- **For Student:**
  - NOC/Leave letter from School/college Authority
  - School, College Photo I D Card copy
- **Visiting Friend or Relative:**
  - 3 months bank statement
  - A letter of invitation from the relative or friend in Australia
  - Proof of legal status in Australia (passport & visa copy)
  - Employment letter & pay slip or University letter
  - Doctor letter (if visiting for medical reason)
- **Hotel Confirmation Voucher**
- **Ticket Booking**
- **Tour Itinerary with Confirmation Letter (If You Are Taking A Schedule Tour)**
- **Visa Application Form: Signed by Applicant (Blue Ink)**
- **PAN card and AADHAR card (Front side and Back side) compulsory.**

**Note:**

- Applicants are requested not to give any Original documents except our necessary demand.
- We will take 3 to 4 days to prepare visa application to submit online.
- Applicant should not purchase non-refundable tickets or accommodation prior to visa issue. Any such purchases are the sole responsibility of the applicant only. We recommend instead that you lodge your visitor/Tourist application well ahead of your purpose travel date and finalize travel arrangements after visa issue.
- Visa issuance is sole responsibility of Australian High Commission; Fidelity Holidays is not responsible for any rejection/refusal or delay in visa.
- Australian High Commission may call applicant for interviewing and ask purpose of visit, available funds and occupation
- All Documents Must in English and A4 size.
- Applying for a visitor visa with you might need to have health examinations.
- Whether you need them, and what examinations you need, depends on:
  - the visa you are applying for
  - how long you plan to stay in Australia
  - what you plan to do in Australia
  - any special circumstances that might apply to you
  - whether you have any significant medical conditions
