

Croatia Tourist Visa

- **Original & all old Passports:**
 - **Note:** Passport should be valid minimum 06 months from the date of travel, Passport has been issued within 10 years and validity must not exceed 10 years, no hand written passports will be accepted and at least 2 blank pages.
- **Photograph:**
 - 02 recent photograph (3.5cm x 4.5cm size, white background, matt finished & 80% face image, without specs & not used in previous visa)
- **Financials:**
 - Last 06 months Personal Updated Bank Statement with bank sign and stamp on each page with sufficient balance
 - Last 03 years Personal Income Tax Returns Acknowledgement Page only
- **For Employee:**
 - Last 06 months Salary Slips
 - Original Leave Sanctioned letter should address to the consulate/Embassy
 - Personal cover letter stating purpose of travel
- **For Self Employed:**
 - Business letterhead with Sign & Stamp
 - Business Registration (For Proprietor – Company Registration & GST Certificate, For Partner - Partnership Deed, For Director - Memorandum of Association)
 - Last 03 years Income Tax Return Acknowledgement Page only
 - Last 06 months Updated Bank Statement with bank sign and stamp on each page
 - Personal cover letter on company/business letter head stating purpose of travel
- **For Retired:**
 - Retirement letter from Employer
 - Pension Payment Order OR Pension passbook.
- **For Student:**
 - Letter from school / university for grant of leave /NOC
 - ID Card Copy of School / College
- **Hotel Confirmation Voucher**
- **Ticket Booking**
- **Tour Itinerary with Confirmation Letter (If You Are Taking A Schedule Tour)**
- **Visa Application Form: Signed by Applicant (Blue Ink)**
- **PAN card and AADHAR card (Front side and Back side) compulsory.**
- **Insurance Policy**
 - Minimum coverage of 30,000 Euro per person, the insurance has to cover the entire stay in Schengen territory.
- **Important Notice**
 - Please pay attention that pursuant to the Government's Decision, the Republic of Croatia applies the Decision No 565/2014/EU according to which all visitor's holders of valid Schengen

documents, as well as national visas and residence permits of Bulgaria, Cyprus, and Romania do not require an additional (Croatian) visa for Croatia.

- Therefore, visitors who are holders of:
- Uniform visa (C) for two or multiple entries, valid for all Schengen Area Member States

- No documents will be return back by Embassy/Consulate after visa process.
- Must declare rejection if rejected in any country in last 10 years and mention rejection year and category of visa of Rejected country.
- All applicants have to pay visa fees, VFS charge & courier charge in cash at local VFS-centre.
- Please note that you may be required to come for a personal interview with the visa officer at the Embassy of the Croatia prior to a decision being made on your application.
