

New Zealand Tourist Visa

- **Original & all old Passports:**
 - **Note:** - Passport should be valid minimum 06 months from the date of travel, Passport has been issued within 10 years and validity must not exceed 10 years, no hand written passports will be accepted and at least 2 blank pages
- **Photograph:**
 - 02 recent photograph of 3.5cm x 4.5cm size, white background, matt finish & 80% face image & not used in previous visa
- **Financials:**
 - 03 years Personal Income Tax Returns with computation of Total Income Page
 - 06 months Personal original Bank Statement updated with sufficient balance
 - Copy of Investments like (P.P.F., SHARES Demat A/c Statement, F.D., L.I.C. Surrender value)
- **For Employee:**
 - Salary Slip (last 6 months)
 - Leave sanction letter and N.O.C.
 - G.P.F (for Government Employee)
- **For Self-Employed:**
 - Business letterhead with sign & stamp & visiting card
 - Business Proof (Shop & Establishment, G.S.T., C.S.T., etc.)
 - Partnership Deed
 - Memorandum of Article
 - 03 Years Income Tax Return with computation of Total Income Page
 - 06 Months Bank Statement
- **For Retired:**
 - Retirement letter from Employer
 - Pension passbook copy
 - Provident Funds copy
- **For Student:**
 - NOC/Leave letter from School/college Authority
 - School, College Photo I D Card copy
- **Visiting Friend or Relative:**
 - A letter of invitation from the relative or friend in Australia
 - Proof of legal status in Australia (passport & visa copy)
 - 03 months bank statement
 - Job letter & pay slip or University letter
 - Doctor letter (if visiting for medical reason)
- **Hotel Confirmation Voucher**
- **Ticket Booking**
- **Tour Itinerary with Confirmation Letter (If You Are Taking A Schedule Tour)**
- **Visa Application Form: Signed by Applicant (Blue Ink)**
- **PAN card and AADHAR card (Front side and Back side) compulsory.**

Note:

- Applicants are requested not to give any Original documents except our necessary demand.
- We will take 3 to 4 days to prepare visa application to submit at High Commission.
- Applicant should not purchase non-refundable tickets or accommodation prior to visa issue. Any such purchases are the sole responsibility of the applicant only. We recommend instead that you lodge your visitor/Tourist application well ahead of your purpose travel date and finalize travel arrangements after visa issue.
- Visa issuance is sole responsibility of New Zealand High Commission; Fidelity Holidays cannot be held responsible for any rejection/refusal or delay in visa.
- New Zealand High Commission may call applicant for interviewing and ask purpose of visit, available funds and occupation.
- All Documents Must in English.

Normal Process Time : 20 working days after submission in New Zealand High Commission.
